

Aged Care Residential Accommodation Pricing

Entry Process

Before entering Great Ocean Road Health aged care residence, all of the following three steps must be undertaken by the incoming residents (or their representative).

1. ACAT/ACAS/NSAF Assessment

This assessment lets us know what type of care a prospective residents may require, and allows us to claim government funding to reduce fees. Aged Care assessments are conducted by external assessment agents called ACAS teams.

Your local GP or health care provider can assist with arranging an assessment, or you can arrange directly via My Aged Care by calling 1800 200 422 or emailing myagedcare.gov.au. Please note, there is usually a wait time for assessments, so please organise in advance.

2. Centrelink/ DVA Assessment

The government requires those who can afford to contribute more towards their care to do so. As such, every person entering aged care, including those applying for a financially supported place, must have an assets and income assessment. This assessment will determine if a resident qualifies for a government supported place or will pay an additional Means Tested Care Fee. 3. Great Ocean Road Health application form

An application form must be completed by all persons interested in becoming a resident at Great Ocean Road Health Lorne or Apollo Bay nursing home.

Aged Care Fees and Charges

What fees can I be asked to pay in residential aged care?

1. Basic Daily Fee (mandatory)

Every person on residential aged care is required to pay a Basic Daily Fee, which covers your day to day living costs such as meals, cleaning and laundry. This fee is set by the government and is based

on 85% of the single Australian Aged Pension. The Australian Government review this fee on 20th March and 20th September in line with the pension.

2. Means-tested care fee (Centrelink Assessable)

The cost of people's care is paid for the Department of Health. Some people may be asked to contribute to this cost of care. The Department of Human Services (Centrelink) will work out if you are required to pay this fee based on an assessment of your income and assets and will advise you of this amount. If you are part of a couple, the assessment will consider half your combined income and assets. These fees are capped annually and over a resident's lifetime

3. Accommodation Payment

Some residents will have their accommodation costs met in full or part by the government, while others will need to pay the accommodation prices agreed with Great Ocean Road Health. The Department of Human Services (Centrelink) will advise you which applies to you based on an assessment of your income and assets. If you are not eligible for government support and you will be paying for your accommodation costs personally, there are payment options available to you.



Our Lorne aged care nursing home is a high level care facility with 20 long term high level care beds and one flexible respite bed, which can cater for high and low level care needs.

The home has a relaxed atmosphere with caring and motivated staff to manage each resident's requirements. We offer a range of services from activities programs, physiotherapy, podiatry, dietician, speech therapy, palliative care and volunteer program to name a few. Being a small facility has its benefits of a family like environment, which the residents feel secure and safe in.

Our facilities are excellent with a mixture of single and shared (double) rooms. Each room has its own en-suite. The facility also has a garden area, activities room and a balcony that overlooks the stunning Lorne bay and the Great Ocean road. Doctor services are provided through the general practice, which is on site, ensuring prompt care if required.

All meals, including morning and afternoon tea are provided and serviced in the dining room.

Accommodation Pricing Options

Option 1 – Refundable Accommodation Deposit (RAD)

A one-off lump sum payment that is fully refundable at the end of your stay with us, less any amounts you have agreed to have deducted (if applicable). The refund is guaranteed by the Australian Government.

Option 2 – Daily Accommodation Payment (DAP)

The lump sum price is converted into a daily payment, which is charged at the maximum permissible interest rate (MPIR) set by the Department of Health.

Option 3 – Combination

The accommodation cost is paid by a combination of RAD and DAP. You can choose the RAD amount and this will then adjust the amount you pay via the daily charge.
